## LETTER OF ACCESS FEE STRUCTURE

The Letter of Access fee structure prepared by REACH Boron Consortium is based on principles of fairness, proportionality, transparency and non-discrimination.

This revised fee structure results from a thorough review of costs, etc.<sup>1</sup> After evaluating the various options for Letter of Access fees, including a flat fee structure and a banded fee structure, it was decided to continue with a per tonne fee structure for the  $\geq 10$  tonnes band, but to change to a flat fee structure for the 1-10 tonnes band. Now that the 2018 registration deadline has passed, the practice of basing LOA fees on the average tonnage of the two prior years is no longer appropriate. Therefore henceforth our LOA fees will be based on the anticipated tonnage of boron or phosphorus to be manufactured in or imported into the EU for the year in question, subject to the applicable minimum fee.<sup>2</sup>

The following fees are now applicable:

- Letters of Access are available on a per legal entity basis
- An administration fee of €250 per Letter of Access will be charged.
- All fees and charges are subject to any applicable taxes such as value added tax [VAT].

In the event that a company which has purchased a Letter of Access at the 1-10 tonnes band wishes to upgrade to a higher tonnage band as per paragraph 2.6 of the Letter of Access Agreement, an additional fee will be payable, based on the per tonne fee for the anticipated tonnage concerned, subject to the applicable minimum fee (less the fee already paid for the 1-10 tonnes band).
